

- 2. TOURNAMENT REFEREES: THE TOURNAMENT CHIEF REFEREE IS EDWIN TUMUSIIME. THE OTHER REFEREES ARE PAUL NSEREKO. EVAH MAGALA AND COLLINS NUWAGIRA, AND THEIR RULING SHALL BE FINAL.
- 3. ENTRY AND REGISTRATION: ALL SENIORS INTENDING TO PLAY MUST REGISTER AND PAY THE SPECIFIED ENTRY FEES BY TUESDAY 20<sup>™</sup> AUGUST 2024.



#### ENTEBBE CLUB LOCAL RULES

THE FOLLOWING LOCAL RULES, TOGETHER WITH ANY ADDITIONS OR AMENDMENTS AS PUBLISHED BY THE COMMITTEE WILL APPLY TO CHAMPIONSHIPS AND MATCHES RUN BY ENTEBBE CLUB. PLAY SHALL BE IN ACCORDANCE WITH THE R&A RULES OF GOLF AND THE LOCAL RULES AND BYE LAWS OF ENTEBBE CLUB

- 1. OUT OF BOUNDS (RULE 18.2): (A) BEYOND ANY WALL, FENCE OR LINE OF WHITE OR STAKES DEFINING THE BOUNDARY OF THE COURSE ON HOLES 1, 2, 3, 4, 5, 6, 11, 12, 15 AND 16. (B) ON OR BEYOND ANY WHITE LINE DEFINING THE BOUNDARY OF THE COURSE. A BALL IS OUT OF BOUNDS WHEN ALL OF IT LIES ON OR OVER SUCH A LINE DEFINING THE BOUNDARY OF THE CRICKET OVAL. (C) IN OR BEYOND THE DRAINAGE DITCH DEFINING THE BOUNDARY OF THE COURSE BEHIND GREEN 13. (D) A BALL THAT CROSSES A PUBLIC ROAD DEFINED AS OUT OF BOUNDS AND COMES TO REST BEYOND THAT ROAD IS OUT OF BOUNDS, EVEN THOUGH IT MAY LIE ON A ROAD RESERVE. NOTE: WHERE OUT OF BOUNDS IS DEFINED BY WHITE STAKES OR FENCE POSTS (EXCLUDING ANGLE SUPPORTS), THE OUT OF BOUNDS LINE IS DETERMINED BY THE NEAREST INSIDE POINTS AT GROUND LEVEL OF SUCH STAKES OR POSTS. A BALL IS OUT OF BOUNDS WHEN ALL OF IT LIES ON OR BEYOND SUCH A LINE.
- 2. ROAD RESERVES ON HOLES 1, 5, 9, 16, 17 AND 18: RELIEF MAY BE TAKEN WITHIN ONE CLUB LENGTH OR FROM THE NEAREST POINT OF RELIEF BUT NOT NEARER TO THE HOLE.

#### 3. NO PLAY ZONES (PLAY NOT PERMITTED):

FLOWER GARDENS ON HOLES TWO AND TEN ARE NO PLAY ZONES. DURING PLAY OF A HOLE, IF A BALL COMES TO REST ON ANY OF THE ABOVE, THE BALL MUST BE DROPPED CLEAR OF THE NO PLAY AREA BUT NOT NEARER THE HOLE, WITHOUT PENALTY.

#### 4. INTEGRAL PARTS OF THE COURSE:

- (A) ANY CABLES OR ADVERTISING BOARDS CLOSELY ATTACHED TO ANY OBJECT DEFINING THE BOUNDARY OF THE COURSE.
- (B) WIRES, CABLES, WRAPPINGS OR OTHER OBJECTS WHERE THEY ARE CLOSELY ATTACHED TO TREES OR OTHER PERMA-NENT OBJECTS.
- (C) RETAINING ARTIFICIAL WALLS AND PILING WHEN LOCATED IN WATER HAZARDS.
- 5. PACE OF PLAY (RULE 5.6b): IN THE INTEREST OF ALL, A PLAYER MUST NOT UNREASONABLY DELAY PLAY, EITHER WHEN PLAY-ING A HOLE OR BETWEEN TWO HOLES. PLAYERS HAVE AN OBLIGATION TO PLAY AT A REASONABLE PACE. SLOW PLAYERS MUST GIVE WAY. IF A GROUP BEHIND IS FASTER, INVITE THEM TO PLAY THROUGH.

#### 6. ABNORMAL COURSE CONDITION (INCLUDING IMMOVABLE OBSTRUCTIONS RULE 16)

- A) ANY AREA ENCIRCLED BY A WHITE LINE.
- B) EXPOSED ROCKS IN AREAS CUT TO FAIRWAY HEIGHT OR LESS.
- C) AREAS IN BUNKERS WHERE SAND HAS BEEN REMOVED BY THE MOVEMENT OF WATER RESULTING IN DEEP FURROWS THROUGH THE SAND.
- D) YOUNG MARKED TREES IDENTIFIED BY A BAND OR STAKE ARE NO PLAY ZONES AND RELIEF MUST BE TAKEN UNDER RULE 16.1F
- E) RELIEF IS AVAILABLE FROM INTERFERENCE TO THE LIE OF THE BALL OR THE AREA OF INTENDED SWING FROM TERMITE MOUNDS IN THE GENERAL AREA. INTERFERENCE DOES NOT EXIST IF THE TERMITE MOUNDS ONLY INTERFERES WITH THE PLAYERS STANCE.
- F) RELIEF WILL BE DENIED FOR INTERFERENCE TO STANCE FROM A HOLE, CAST OR RUNWAY MADE BY A BURROWING ANI-MAL, A REPTILE OR A BIRD.
- G) IF A PLAYER'S BALL IN THE FAIRWAY HAS INTERFERENCE FROM TREE ROOTS, FREE RELIEF IS AVAILABLE. BUT INTERFERENCE DOES NOT EXIST IF THE TREE ROOTS ONLY INTERFERES WITH THE PLAYERS STANCE.
- H) DRAINAGE CHANNELS ON HOLES 4, 8/9, 10, 16 AND 17/18 ARE IMMOVABLE OBSTRUCTIONS.

#### 7. STOPPING PLAY /RESUMING PLAY (RULE 5.7): (IMMEDIATE AND NORMAL).

A SUSPENSION OF PLAY FOR A DANGEROUS SITUATION WILL BE SIGNALED BY ONE PROLONGED AIR HORN. PLAYERS MUST LEAVE THE COURSE IMMEDIATELY.

ALL OTHER SUSPENSIONS WILL BE SIGNALED BY THREE CONSECUTIVE AIR HORNS, REPEATED.

IN EITHER CASE, RESUMPTION OF PLAY WILL BE SIGNALED BY TWO SHORT AIR HORNS, REPEATED.





**8. DISTANCE MARKERS:** IN THE FAIRWAY ARE MARKED TO THE CENTRE OF THE GREEN. DISTANCE POLES IN THE ROUGH ARE APPROXIMATELY; YELLOW - 250 YARDS, BLUE - 200 YARDS, WHITE - 150 YARDS AND RED - 100 YARDS.

#### IN THE EVENT OF A DISPUTE ARISING AS TO THE MEANING OF ANY RULE OF GOLF OR LOCAL RULES AND TERMS OF THE COMPETITION, THE RULE WILL BE INTERPRETED ACCORDING TO THE ENGLISH EDITION OF THE OFFICIAL GUIDE OF THE RULES OF GOLF EFFECTIVE JAN 2019 AS PUBLISHED BY THE R&A LIMITED.
